COMPANY COMMITMENT

- YPC is not a class, it is a preprofessional young artist company intended for dedicated performers committed to training and working alongside industry professionals, including union performers and production teams.
- Company members give priority to Main Stage/Youth Performances when dates are set in advance. If your child is heavily involved in other activities, we recommend inquiring about the YPC Apprentice Track.
- Performers are expected to attend all rehearsals and performances they have committed to.
- Parents/performers will be expected to communicate clearly when they will be absent from rehearsals or performances, their attendance is crucial to the success of the group. Excessive absences (3 or more in a season) will affect performance opportunities.
- Additional rehearsals may be scheduled as performances approach.
- Professional behavior is expected at all times. This includes being respectful of instructors, guest teachers, and other performers, coming to rehearsals and performances prepared, and studying material at home when needed.

COMMUNICATION:

- Most all communication will be sent via email. Parents/performers should check their email regularly.

- Absences or other YPC related info should be sent via email, the Remind app, or by leaving a message on the company voicemail, 707-200-1778.

FEES:

 Company fees are paid bi-annually and are due by the first rehearsal of each season (there will be reminders sent out the week prior). Payments can be made with a credit card online or cash/check (checks can be made out to "Main Stage"). ATTIRE:

PERFORMANCES:

- Black jazz shoes (slip-on or lace-up)
- Plain black flats or dress shoes (for outdoor performances)
- PLAIN black pants (no leggings) OR black tights/skirt (no tears, rips, designs, or rhinestones)
- Black tank top/bike shorts OR Black tank leotard
- Black YPC shirt (\$25-orders to be placed at the beginning of each season)
- All other items will be provided from company stock
- No jewelry/watches during performances except stud earrings (this is for performer safety)
- Generally performers do not wear stage makeup

REHEARSALS:

- Jazz shoes should be worn to rehearsal unless otherwise specified
- Performers should be dressed for movement leggings, sweats, shorts, t-shirts/tank tops. No jeans or clothes that restrict movement
- Hair should be pulled back out of face
- MASKS WILL BE REQUIRED AT ALL REHEARSALS THROUGH AT LEAST THE END OF 2021

MATERIALS: Music binders are provided to performers. Performers are expected to bring them to rehearsal each week.
